Ladera Ranch is one of the only unincorporated communities in Orange County that has an active quasi-governmental body, the Ladera Ranch Civic Council (LRCC). The LRCC is the precursor to a local incorporated government that provides input to the Orange County governing boards as the Ladera Ranch civic representation. Over the years, we have made strides in community engagement and partnerships with our local businesses.

The Orange County Local Agency Formation Commission has endeavored to complete a South Orange County Governance Visioning Process Report in 2016. Over four years later, the same areas studied, including Ladera Ranch, remain unincorporated and without any concrete plan for moving forward towards incorporation or annexation.

We acknowledge that the current pandemic has made it difficult to organize and engage with the community. However, we wish to remind the Commission that LRCC remains dedicated to working with the OC LAFCO staff and Commission, and moving forward with a path towards incorporation.

When the Commission deems it safe and appropriate to resume community gatherings and engagement, we look forward to working together again. We believe that the best path forward is together.

Good afternoon,

I would like to submit the following public comment for tomorrow's OC LAFCO Board meeting. Please confirm receipt.

I have lived in south Orange County for 12 years, and the last five years have been in Ladera Ranch. During that time, I have served on several boards in support of my community - including the Ladera Ranch Civic Council, LARMAC (Ladera Ranch's Master HOA), South Orange County Economic Coalition (ECONPAC), and OCTA's Citizens Advisory Committee. Professionally, I have worked in land use planning and transportation for 20+ years.

I offer this background as context in communicating my sincere appreciation for the mission of LAFCO, this board, and our 5th District Supervisor Lisa Bartlett (specifically). You all have many demands on your time and competing interests to balance, so I appreciate your continued focus in representing our unincorporated communities.

While serving on the Ladera Ranch Civic Council between 2017-2019, I did my homework in coming to realize incorporation is complicated and timing is everything. I met with Supervisor Bartlett and her staff; Carolyn Emery and her staff; Dan Kelly, Mike Basalmo, and Jeremy Laster from Rancho Mission Viejo (RMV); Greg Rath, then-Mayor of Mission Viejo; and even State Senator Pat Bates, as a former champion of incorporation for the City of Laguna Niguel. I've also participated in California (Un)Incorporated's efforts to revive the Vehicle License Fee (VLF) as a funding mechanism for incorporation. I am an avid supporter of small government and local control, but the current legislative and economic climate poses real challenges to incorporation unless our south county unincorporated communities discuss a "path forward" together.

To that end, I want to share three points:

1. Regardless of financial feasibility, I believe it would be a mistake for Ladera Ranch to incorporate on its own. Geographically, Ladera Ranch is the central link connecting Coto de Caza, Wagon Wheel, Stonecliff, and Las Flores to the north and Rancho Mission Viejo (RMV) to the south. Upon build-out in the next 10-15 years, the best chance for economic vitality will come from these communities incorporating together as one City.
2. In response to my fellow Ladera Ranch resident's comments last month, I agree that LAFCO should "re-run the numbers" to understand the viability of incorporation, but not yet. It is prudent to wait until the 2020 Census results are available this Summer and we are no longer in a down economy from COVID.
3. I recognize it's in your 2021 Strategic Plan to start re-engaging stakeholders from the South Orange County Visioning Study completed in 2016. I respectfully request that you not limit the dialogue to just representatives of the Ladera Ranch Civic Council (relative to my community). There are several very engaged champions of Ladera Ranch who know our community well and work hard behind the scenes to make it the best it can be, now and into the future. Please keep us posted on how we can help LAFCO going forward.
