SUBJECT: OC LAFCO Fiscal Year 2020-2021 Work Plan Mid-Year

Update

#### **BACKGROUND**

On August 12, 2020, the Commission approved the Fiscal Year 2020-2021 OC LAFCO Work Plan (*Attachment A*). The Work Plan identifies major projects and activities for the current fiscal year that align with the five strategic focus areas outlined in the agency's 2019 Strategic Plan. This report is a mid-year update on the accomplishments and progress of the Work Plan's key areas and staff activities. The focus areas include: (1) Project Applications; (2) the Fourth Cycle – Sphere of Influence (SOI) Reviews and Updates & Municipal Service Reviews (MSRs); (3) the OC LAFCO Unincorporated Areas Program; (4) South Orange County Future Governance, and; (5) Outreach and External Relations (OC LAFCO Communications Plan). Additionally, this report includes an update on the completion of key administrative projects.

The Commission's Executive Committee meets periodically with the Executive Officer to discuss the progress and potential adjustments to the approved Work Plan. The current Committee members (Chair Douglass Davert, Vice Chair Donald Wagner and Immediate Past Chair Derek McGregor) were appointed by the Commission at the December 9 regular meeting and is scheduled to meet in early February to discuss activities occurring up through the second quarter, the proposed FY 2021-22 budget and other key agency activities.

#### DISCUSSION

### **Project Applications**

In accordance with the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 ("CKH Act"), OC LAFCO is required to efficiently process applications for changes of organization or reorganization. Annually, the Commission identifies filed and anticipated applications in its work plan and establishes that these projects shall take precedence over other agency activities. The FY 2020-2021 Work Plan adopted on August 10, 2020 included six projects involving city/district annexations and reorganizations and a sphere of influence review and update. Since adoption of the Work Plan, two new projects (Newport Beach Harbor Patrol Service Municipal Service Review and a detachment from the City of Tustin) have been added to this area. Many of these projects have been deemed incomplete due to the pending application requirements. The table below summarizes the projects and identifies the anticipated Commission hearing dates based on the prework completed and pending requirements for each project. Additional details on the projects are provided in **Attachment A**.

# Fourth Cycle - Sphere of Influence (SOI) Reviews and Updates & Municipal Service Reviews (MSRs)

The fiscal year 2020-2021 Work Plan identified the following activities of this project to be completed by June 30, 2021: 1) Update agency fiscal indicators; 2) Integrate the Municipal Services Dashboard and Shared Services Web Program with newly designed agency website; and 3) Preparation of three regional MSRs (OCSD, MWDOC and County

Service Areas 13, 22 and 26). Below is a summary discussion on the status of each of these areas.

#### Fiscal Indicators Program

During the current fiscal cycle, staff began working on the updating of the Commission's current fiscal indicators program. Components of the effort include refinement of the fiscal indicators, updating of the web program with current agency fiscal data, and integration of the web-based program with the agency's website that is currently under construction. Six months into the work plan, the fiscal indicators have been simplified and updated in effort to be more resourceful to local agencies and services providers, as well as the public. The updating of the fiscal data and integration of the web-based program with the new website will be completed during the second half of the work plan cycle.

MSR Dashboard and Shared Services Web Program The MSR Dashboard and Shared Services Web Program are interactive technology tools used to maintain the demographic information and shared service arrangements and opportunities discussed in municipal service reviews. The Dashboard platform was developed in October 2020 and the population of the dashboard with



demographical and other data for Orange County cities, special districts and other local service providers is currently underway.



The Shared Services Program improvements were completed during the previous work plan cycle and both tools will be launched with the agency's new website in February. Following the launch, an interactive showcase of the programs will be presented to the Commission during a regular board meeting.

### Preparation of MSRs

During the first quarter of the work plan cycle, two MSRs (MWDOC and OCSD) were completed by the Commission. Two additional MSRs (CSA 13 and 22, and CSA 26) are expected to be completed by June 2021. The MSR for the County Service Areas was initially expected to be a single MSR that reviewed the regional service delivery within these areas. However, since the City of Newport Beach has filed an application for the preparation of an MSR that focuses on the delivery of harbor patrol services currently

provided by CSA 26, the work plan has been amended to reference the preparation of the CSA 26 MSR parallel to the processing of the City's application. It is expected that preparation of the MSR for CSA 26 and processing of the City's application will be completed in Summer 2021.

#### **OC LAFCO Unincorporated Areas Program**

The success of the Commission's Unincorporated Areas Program is attributed largely to the collaborative effort of LAFCO, the County and cities with a high interest in annexing unincorporated areas located within their sphere of influence. While there has been minimal activity involving the potential annexation of the County's remaining 26 unincorporated areas during the first part of the current work plan cycle, it is anticipated that an application will be filed by the City of Placentia to annex the Hamer Island during the second part. Staff did engage in preliminary discussions with the City of Newport Beach staff regarding the annexation of the Banning Ranch area. However, at this time an annexation application is not expected.

#### **South Orange County Governance**

During the first half of the current work plan cycle, staff continued to meet quarterly with the Rancho Mission Viejo (RMV) development representatives to stay apprised of the timeline for development within six planning areas. With two phases complete (Sendero and Esencia) and phase three expected in 2022, staff learned that home sales have gradually improved and have not been adversely impacted by the pandemic. Quarterly meetings with RMV representatives will continue during the second half of the work plan. Additionally, after January 1 staff will reengage the outreach to the South Orange County Unincorporated Communities (SOCUC) regarding participation in the stakeholder working group process to discuss future governance. To date, the Ladera Ranch community has expressed interest in participating. However, Commission staff has been unable to meet with the other communities due to the pandemic or lack of response.

#### **Outreach and External Relations**

Implementing new communications tools and enhancing existing vehicles is one of the Commission's key priorities for the current fiscal year. During the past six months, the following milestones for this strategic area were completed or are underway:

#### Completed:

- ✓ Rebranding and development of the agency logo, tagline, and letterhead
- ✓ Developed agency key messaging and talking points
- ✓ Designed portable messaging deck for Commissioners and staff

- ✓ Developed "OC LAFCO External Communications Guidelines" (to be reviewed by the Executive Committee)
- ✓ Developed and implemented Social Media Calendar

#### **Underway:**

- o Development of monthly "Hot Sheet"
- o Development of bi-annual newsletter

#### **Administrative Projects**

The OC LAFCO FY 2020-2021 Work Plan includes six administrative projects to support the Commission's efficient and cost-effective operational management practices. Below is an update and the status of these projects. Additional details on these projects are also included in **Attachment A**. As noted in the attachment, one of these projects, which includes the development of the fiscal year 2021-2022 budget will begin in February 2021.

#### **Completed Projects**

#### (1) Annual Audit

Preparation of the Commission's annual audited financial statements for FY 2019-2020 with no material (significant) issues noted.

#### (2) CALAFCO

Commissioners and staff continued their participation with CALAFCO during the first part of the current fiscal year. Former Chair and Commissioner Cheryl Brothers was reelected to the CALAFCO Board of Directors and continued serving until early December. Policy Analyst Luis Tapia continued participation on the CALAFCO Legislative Advisory Committee and was reappointed to the committee this past December. Commissioners and staff also participated as panelists and attendees in multiple webinars hosted by CALAFCO that included subject matter on adaptive leadership and LAFCO's role in proactively supporting local service providers in lessening economic impacts and maintaining service levels in spite of the myriad of current economic crises.

At present, the CALAFCO 2021 Staff Workshop is scheduled to take place in Newport Beach, March 17th through 19th. Due to the current pandemic, it is anticipated that the Board will discuss whether the workshop will go forward at its next meeting on January 21. Should the event move forward, Orange and Imperial County LAFCOs will serve as the workshop co-hosts.

Additionally, Commissioners and staff continued participation in quarterly meetings involving the southern region LAFCOs (Imperial, Los Angeles, Orange,

Riverside, San Bernardino, and San Diego) to discuss and collaborate on regional and local issues. During the December regional meeting, the southern LAFCOs voted to support Aquanetta Warren, San Bernardino Commissioner and Mayor of the City of Fontana to fill the CALAFCO board seat formerly held by Cheryl Brothers.

#### (3) OC LAFCO Records Systems and Projects Database

Completed improvements to the archival and records retrieval system and implemented the Lasefiche document management and storage system.

#### (4) Agency Website Redesign

Over the past six months, staff has worked with the LAFCO consultant on the redesign of the agency's website. Significant progress has been made on the agency platform design and other key milestones that include content development, and the integration of the MSR dashboard and Shared Services Programs are underway. The new website is expected to launch in February 2021.

#### (5) Joint RFP Process for Auditing Services

The joint collaboration with our southern partners (Imperial, Los Angeles, Riverside and San Bernardino LAFCOs) was completed in November that included a competitive bidding process for the selection of an independent auditor to prepare each LAFCO's audited financial statements beginning 2021 through 2024.

Additional administrative activities completed during the first six months of the fiscal year include the Assistant Executive Officer recruitment and development of policy and procedures in response to federal and state laws involving the Coronavirus. While these activities are not referenced in the Work Plan, each required significant staff time, therefore, are worth noting in this update.

#### STAFF RECOMMENDATION

At the mid-year point, the Commission has completed many project milestones within each of the agency's five Strategic Focus Areas. The second half of the work plan cycle is expected to involve the processing of applications, conducting of sphere reviews, preparation of MSR reports, and engagement of South Orange County unincorporated communities on future governance. Additionally, efforts will be expended on the continued implementation of the agency's communications plan. The next update on the agency's work plan will be a year-end report at the July regular meeting.

### Staff recommends that the Commission:

1. Receive and file the FY 2020-2021 Work Plan Mid-Year Update.
